Updates: ScotPHO

- Online profiling available on website December 2012
- Drug, alcohol and tobacco use profiles March 2013
- Community health profiles Summer 2013
- Alcohol Population Attributable Fractions (PAFs) are being updated and Drug PAFs for Scotland created
- New topics are being added to ScotPHO website on topical issues (e.g. vitamin D and assets) and diversity strands
- Updated Health For All database November 2012
- Health Inequalities Tools for Scotland (HITs) for alcohol brief interventions, smoking cessation and counterweight – end September 2012 – future extension into wider range of interventions

- Human Papilloma Virus (HPV) vaccination uptake rates, prescribing statistics and smoking cessation service uptake –
 September 2012

 Report of pilot study collecting pre-school development data and linking to subsequent and health and social outcomes – October 2012

[has relevance to future routine monitoring of health inequalities across the lifecourse]

- Scottish Health Survey (SHeS) topic reports
 - Obesity Older People's Health Equalities Groups Oct 2012
- Scottish Health Survey (SHeS) Annual Report September 2012
 - separate volumes for adults and children
 - web tables including health board breakdowns for 2008-2011



- Long term monitoring of health inequalities every October
- Indicators to monitor progress of the Prevention of Obesity Route Map – every October
- Harmonised core for SG large population surveys
 - Results will be pooled across surveys, increasing opportunities for smaller geographical and more detailed analysis.
 - First results due end 2013.
- Programme Budgeting testing the approach in Scotland
- Social Capital and Health findings from the Scottish Health Survey and Scottish Social Attitudes Survey- forthcoming
- Evaluation of the Family Nurse Partnership Programme in NHS Lothian- Late Pregnancy and Postpartum
- Alcohol Minimum Pricing Model updated
- Active Nation Legacy Baseline September 2012



Updates: GCPH


- A number of projects being discussed today...
